







Insecticide for professional use against bedbugs, fleas, moths (and their larvae), beetles (and their larvae), cockroaches, files, mosquitoes, wasps. For use in all types of domestic, commercial and industrial premises including kitchens, hotels, domitlories, steeping areas, hospitals (excluding occupied wards), military establishments and food storage and processing areas.

Directions for use:

Add a small quantity of water to a suitable compression sprayer and then add product according to the table below. Add the remainder of the water, close the sprayer securely, shake to mix contents. Pressurise according to the sprayer manufacturer's instructions. One litre of ready-for-use spray treats 20 square metres of surface. Make up spray as required. Do not store spray overnight.

Apply as a coarse low pressure spray. Some surfaces will absorb more spray, e.g. brickwork or concrete, whereas surfaces such as metal or plastic will allow spray to easily run off significantly reducing the deposit rate of the active material on the surface. Several passes of a light spray each allowed to dry is more effective when retaining non-procus surfaces.

Bedbugs: Apply spray to harbourages and resting places on bedframes, headboards and to cracks and crevices around or near the sleeping area. Pay special attention to any loose wall coverings near the sleeping area and to cracks and crevices in bedroom fittings and furniture. Treat under loose floor coverings and around doorframes, picture frames and wall cupboards etc.

Fleas: Prior to treatment, thoroughly vacuum the area and seal the contents of the vacuum bag before disposal in the refuse. Apply spary to carpets and soft furnishings, including the underside of cushions and to areas regularly occupied by domestic animals.

Cockroaches and other crawling insects: Apply to areas where insects are found, e.g. skirting locards, storage areas, around water pipes, doorframes, window frames, around and behind refrigerators, cabinets, sinke, stoves and the underside of drawers and shelves and to cracks and crevices behind wall-mounted units or flottures.

To avoid risks to man and the environment, comply with the instructions for use. The (COSHH) Control of Substances Hazardous to Health Regulations 2002 may apply to the user of this product at work. Avoid excessive contamination of coveralls. Do not contaminate foodstuffs, eating utensits or food contact surfaces. This material and its container must be disposed of in a safe way. Unprotected persons and animals should be kept away from treated areas until surfaces are dry. Cover all water storage tanks before application. All bats are protected under the wildlife and countryside act 1981. Before treating any structure used by bats consult Natural England, Socitish Natural Heritage or the Countryside Council for Wales. Hazardous to bees. Action should be taken to prevent foraging bees gaining access to treated nests, preferably by removing the combs or blocking the nest entrance. Exclude animals during application. Do not apply fleedly to animals. Do not apply to clothing and human bedding. Wash hands and exposed skin before meals and after use. Keep in a safe place.
